THE BOARD OF TRUSTEES AND THE WORKINGS OF THE TRUST

1. The Board of Trustee shall be consisting of all the trustees at a given time.
2. WORKING OF THE TRUST:
 - i) For the day to day working of the trust affairs the board of trustees shall have the following office bearers, to be elected from amongst the trustees of the trust at a given time:-
 - a) One President
 - b) One Vice President
 - c) One General Secretary
 - d) One Treasurer.
 - ii) The quorum of for the meeting of the board of trustees shall be 75% Presence of trustees at the given time.
 - iii) The Board meetings shall be presided over by the President and in his absence by the Vice President.
 - iv) The Board of trustees shall have at least two meeting in a year.
 - v) Every trustee shall have one vote and the decision shall be by majority. In case of equality of votes the President of the meeting will have a casting vote.
 - vi) The Board of trustees shall have all the rights and liabilities as specified in the Deed of trust.
 - vii) The election for the office-bearers shall be within three months from the date of execution of the trust deed.

- Establishment and maintenance of hostels and/or boarding House and grants free boarding and lodging to poor and deserving students studying in any school colleges, and educational institutions or receiving Education or training and upon such terms and for such period in each case as the trustees may deem fit.
- Grant monetary assistance including 'scholarship and/or loans to poor students whom the trustees may deem to be deserving thereof to enable them to receive such -Education, vocational, industrial, commercial, technical scientific, physical, sociological, journalist and Art and Crafts and upon such terms and for such period in each case as the trustees may deem fit.

(b)(a) If and so of ten as to the trustees or any of them or any trustees or trustee of this deed appointed under any statutory power or by a Court of competent jurisdiction shall die or desire to be discharge from or refuse or neglect or becomes incapable or unfit to action the trusts of this deed, surviving, or continuing trustees or transfer for the time being may whenever the umber trustees of this deed shall be reduced to less than four shall appoint new trustees or new trustees shall be additional and shall not prevent the execution or exercise of any statutory bower to appoint new trustees/trustee.

(b) If at any time either before or after a vacancy shall occur in the number of trustees hereby appointed the trustees shall consider it expedient to appoint an additional trustees or additional trustees of this deed it shall be final and lawful for them to appoint any person or persons whom they may select to be such additional trustees or trustee and on every such appointment the trust property shall as soon as circumstances shall conveniently admit b e transferred to or vested in the trustees necessary or incumbent on the trustees or trustee for the time being to procure the trust property or so much or much part thereof as aforesaid to be so transferred to or vested in them or him until the number of trustees qualified and competent to Act under this deed shall have been reduced to three but every trustee so appointed may as well such part thereof as aforesaid shall have been so, transferred or vested, execute all the trusts, powers and discretions of this deed and in all respects action the same manner as if he had been hereby constituted as trustee.

(c) Every person who shall be appointed a new or an additional trustee of this deed must be a citizen of India and must not be permanently resident outside a radius of fifty miles from the said town.

(d) That the number of the trustee shall at any and no time be less than four.

(e) Any trustee may be removed from the trust by 2/3rd majority vote of the board of trustees.

(f) Any trustee if not willing to continue to be trustee may resign at any time from the trusteeship.
